Engagement of Part-time Doctor (Allopathic System)

CSIR - Centre for Cellular and Molecular Biology, Hyderabad, a laboratory under the aegis of Council of Scientific & Industrial Research (CSIR), New Delhi, desires to engage Male Part-time Doctor (purely on temporary basis) at CSIR-CCMB Dispensary for OPD treatment of its Employees, Pensioners and their dependent family members. The qualification, age and other details are as follows:

| Essential Qualifications | MBBS degree from recognized University / Institute |
| Desirable Qualification(s) / Experience | Post Graduate Degree/Diploma in Medicine/Paediatrics/Obstetrics and Gynaecology or equivalent. Male candidates having atleast 3 years experience in Govt. Hospital / Dispensary of any CSIR Labs/Institutes will be given preference. |
| Nature of Work | Perform the duties of general Medical Officer irrespective of the fact whether individual is a specialist or not. He/she will have to attend the OPD at CSIR-CCMB dispensary. This includes treating common medical ailments and referring the patient to the empanelled hospital, if required, follow-up of chronic disease patients. |
| Upper age limit | 65 years |
| Tenure | Initially, for a period 1 year and extendable further as per CSIR norms. |
| Emoluments | Selected candidate will be paid a consolidated honorarium of Rs. 46,020/- (Fourty Six Thousand Twenty Rupees Only) per month for performing 03 hours' duty as per CSIR guidelines issued from time to time |
| Duty Hours | Part-Time Doctor will have to work for three hours per day (except Sunday and Gazetted holidays) during the dispensary timings based on the requirements of the Institute. |
| Selection Procedure | The Part-time Doctor will be selected on the basis of performance in "Walk-in-Interview". Preference will be given to those who have desirable qualification(s) and experience. |

Candidates fulfilling the above mentioned Essential Qualifications, Age etc., may attend the Walk-in Interview on 18 June 2026, at Committee Room No. 02, CSIR-CCMB at 10:00 AM along with application form (attached herewith) duly filled with photocopies of necessary certificates along with original certificates for verification and 01 passport size colour photograph.

Reporting Time for the candidates for Document verification will be 9:30 AM.

General terms and conditions:

1. The date for determining age/qualification and experience shall be the date of the walk-in interview.
2. No TA/DA will be paid to the candidates for attending the walk-in interview or for joining, if selected.
3. The above position is purely temporary on Contract basis. Candidate engaged in this position will not have any right implicit or explicit for consideration for regularization/absorption against any CSIR/CCMB post(s).
4. **Leave:** The Part-time Doctor would not be entitled for any kind of regular leave. However, they will be entitled for 12 days leave in a calendar year, to be calculated on pro-rata basis.
5. **Tax deduction at Sources:** The income Tax or any other tax liable as per the prevailing rules will be deducted at source before effecting the payment for which the office will issue TDS certificate.
6. **Confidentiality of data, information and documents:** The information, data and documents related to the patients shall remain confidential. No one shall utilize or publish or disclose to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for the office, without the express written consent of the office. The Part-time Doctor is bound to hand over the entire set of records to the office before the expiry of the contract.
7. **Conflict of Interest:** The Part-time Doctor (Male) engaged by this office, shall not represent or give opinion or advice to others in any matter which is averse to the interest of this office.
8. Canvassing in any form and/or bringing any political influence or otherwise will be treated as a disqualification for the above position.
9. **Termination of Service:** The engagement may be terminated at any time by the office without assigning any reasons by giving a notice of 30 days. In case, a part time medical officer desires to leave the contract/job, he/she has to serve the notice before 30 days which can be curtailed/extended at the discretion of the Appointing Authority.
10. Eligible candidates must bring with them all Original requisite documents viz. Date of Birth, Educational Qualifications, Community, Experience(s) and PPO (in case retired from service) etc., at the time of Walk-in-Interview. In case of failure to bring the original certificate, candidates will not be allowed to appear for the interview.
11. The engagement of Part-time Doctor (Male) is subject to the terms and conditions issued by CSIR in this regard from time to time. For all intent and purposes, the services of part time medical officer will be under administrative control of the Director, CSIR-CCMB.
12. The decision of the Director, CSIR-CCMB in all matters relating to eligibility, acceptance or rejection of applications and mode of selection will be final and binding on the candidates.
